Echo View Dalmatians guarantees this puppy to be free from any and all hereditary defects that would render it unsuitable as a companion dog.

Please note: This rather extreme contract reflects several undesirable outcomes of agreements that have lately been experienced by us.

They reflect the changes in our society and its ever increasingly litigious nature and the banality of humans, who, unfortunately are not dogs.

The above named puppy is purebred, the pedigree is correct to the best of the breeders knowledge, and given at the time of sale, and this pup will be registered with the Canadian Kennel Club and the registration papers, transferred into the purchaser's name(s), will be provided by the breeder after all said conditions are met. The health of this pup is excellent to the best of our knowledge and belief at the time of sale. This puppy has had the appropriate inoculations as stated. If this puppy is being shipped into the U.S.A all prices for puppies are in US funds (deposit, balance and cost of a puppy shipping crate at market value. If traveling by air a health certificate signed by a licensed veterinarian must accompany the puppy at buyer's expense. **(shipping charges and or transportation costs and health certificates are the responsibility of the purchaser.)**

1. **HEALTH GUARANTEE:** At the expense of the buyer, this puppy must be taken to a licensed veterinarian for a thorough examination within **five (5) days** upon receiving the puppy. A signed statement from the veterinarian as to the pup's condition must be postmarked and sent to the breeder within **five (5) days** of the examination. If shipped by air, a signed statement from the veterinarian as to the pup's health condition must be postmarked and sent to the breeder within five (5) days of the examination. **FAILURE TO DO SO WILL RELIEVE THE BREEDER OF ALL LIABILITY.**

If this puppy is found to be ill on this examination, the breeder must be notified immediately and the puppy returned to the breeder at the buyers expense **within 48 hours** with a signed, dated statement from the veterinarian on the pup's health condition. The breeder agrees to a cash refund. *N.B. (All shipping charges and or transportation costs are the responsibility of the purchaser.)

TEMPERAMENT: Should the buyer question the temperament of this pup, the buyer must notify the breeder within 48 hours of receiving the puppy. If necessary, the puppy may be returned to the breeder at the buyer's expense for evaluation. Unless the breeder deem the temperament problem to be the result of improper handling (lack of proper socialization, teasing or other abuse) by the purchaser, family members or his agents, the breeder will replace the puppy with one of equal value when a puppy becomes available. Full refund of purchased price at the discretion of the breeder and full refund is limited within the first 48 hours of ownership of the puppy. *N.B. (All shipping charges and or transportation costs are the responsibility of the purchaser.)

RETURN POLICY: If at any time, for any reason, the Buyer finds that they are unable or unwilling to continue to care for this Dog, the Buyer agrees to contact the Seller **FIRST**. The Buyer is required to inform the Seller of such an issue as soon as possible. The Seller always gets first right of refusal upon decision made by Buyer to re-home the Dog sold to them by the Seller. In the event of relinquishment, the Buyer agrees to either transport Dog to the Seller or pay the transportation fees to Seller. Buyer agrees that at the time of transfer of the Dog back to Seller any and all registration papers and medical records will be turned over to the Seller, and all necessary paperwork will be signed transferring ownership back to the Seller. Registration of Microchip or other permanent form of identification will be transferred to the Seller. All transfers must be complete upon transfer to Seller. If Seller is not notified regarding a transfer of Dog in any such way, it will constitute a breach of contract. In the event of Buyers death, family or power of attorney should notify the Seller immediately.

This dog/bitch will never be sold or given to any retail or wholesale place where dogs are sold or resold neither to the public, or to any research institution where experimental practices take place. _____ Initial here as being read and understood

Pet Puppies:

This pup is sold as a pet quality only and cannot be used for breeding purposes because:

- 1) the dog possesses one or more major and/or disqualifying faults including but not limited to one or two blue eyes.
- 2) the dog may possess only one descended testicle or incorrect bite.
- 3) the buyer understands that their chosen pet quality puppy may be BEAR tested unilateral. (deaf in one ear) 4) the buyer has promised to never use the dog/bitch for breeding purposes.
- 3) the buyer understands that this puppy is for its lifetime registered with the Canadian Kennel Club on a non-breeding contract
- 4) the buyer agrees to neutered/spayed the puppy between the age of 10 to 12 months of age.
(A copy of the neuter/spay certificate must be forwarded to the breeder before the registration certificate is transferred into the buyers' name.)
- 5) the buyer understands that this puppy must attend at least one (1) set of puppy socialization/obedience classes by the age of 6 months and a copy of the certificate from the training center must be forwarded to the breeder.

Therefore this sales transaction will only be deemed complete upon presentation to the breeder the following:

- 5) a. Sterilization is to be performed when the said dog is 10 - 12 months old and at the purchaser's expense. Proof of sterilization by way of a veterinarian certificate identifying said dog by its tattoo/microchip number.
b. the puppy must attend one set of puppy socialization/obedience classes before the pup's 6 month's birthday and a copy of the certificate from the training center must be forwarded to the breeder Until such time, said dog's registration paper will remain in the breeder's name.
- 6) **If the breeder determines by ANY means that the puppy/dog is not being suitably cared for or that it might be or has been mentally or physically mistreated, or that this contract has not been fulfilled, the Breeder reserves the right to take full possession of the puppy/dog along with its properly signed CKC transfer papers/registration, without compensation. The Breeder's opinion is the ONE AND ONLY authority required to justify this action. Testimony of other people will not supersede the Breeders judgment on this matter.**

Under such circumstances, all warranties are then void.

I/we, the purchaser(s) understand agree and will abide to the above agreement and place my signature(s) here.

The buyer agrees to contact us (the breeders/sellers) about small problems, so they can be resolved before they become big problems.

We **do not** support early spaying or neutering that is before 8 months of age as the pup require many of the related hormones for proper development of bones etc.

Please be aware that the breeder selects the puppies for the buyers.

Most times we'll give you a choice of 2-3 puppies.

We alone know each and every puppy's temperament and quirks and we match personalities.

We guarantee you will be very happy with the selection.

The breeder reserves the right to terminate the sale of any puppy for any reason after the application has been approved and up to the time of the buyer receiving possession of the puppy.

Please be aware and understand your obligations to the breeder.

Violations of This Legal & Binding Contract Will Entitle the Breeder To \$2,500.00 Dollars in Liquidated Damages.
